## ENHANCING CULTURE AND CONDUCT IN BANKING

We understand that building human capital is as important for banks as maintaining financial capital. Our long history of embedding professional ethics and expertise means we are well placed to complement and support the work of regulators and banks to enhance and sustain customer-focused, ethical professionalism in banking. This encompasses the Senior Managers Regime, Certification Regime and a new set of Individual Conduct Rules.

In 2014, the Prudential Regulatory Authority and Financial Conduct Authority set out their proposals for:

- A Senior Managers Regime to cover a narrow range of individuals with significant responsibility within banks and other relevant firms
- A Certification Regime to cover 'material risk takers' not included within the Senior Managers regime, individuals who could cause harm to consumers, and individuals in customer-facing roles subject to qualification requirements
- New Individual Conduct Rules, which must be complied with by the majority of bank employees.

## Meeting the requirements of the Certification and Senior Managers Regimes

- Annual re-accreditation and certification of individuals through ongoing professional membership of the UK's banking institute, supported by a wide range of continuing professional development (CPD) resources including an Ethics, Culture and Conduct. Launched in 2014, the toolkit contains more than 12 hours of audio, video, e-learning and other materials
